We use personal information for the following purposes:

Legal Basis for Processing

- Compliance with legal obligations
- Your consent, where required under applicable laws

Consequences of Not Providing Personal Information

Data Recipients

Personal information may be accessed or shared with:

- Professional advisors, tax consultants, financial institutions, and government authorities where required for legal, tax, accounting, or contractual purposes.

- Auditors (internal and external)
- Clients, where required under contractual obligations
